1. *Nanyang Technological University (NTU)* Singapura menawarkan program beasiswa MBA dengan masa pendidikan 1 (satu) tahun yang ditujukan untuk para pegawai senior/pejabat (*mid-career executives*). Program ini bertujuan untuk mengembangkan kompetensi pemimpin dengan berfokus pada kurikulum pendidikan secara global, serangkaian seminar kepemimpinan dan *Overseas Business Study Mission*;
2. Pendaftar beasiswa harus memenuhi ketentuan sebagaimana tercantum dalam Peraturan Menteri Keuangan Nomor 18/PMK.1/2009 tentang Tugas Belajar di Lingkungan Kementerian Keuangan.
3. Persyaratan penerimaan dari NTU meliputi:
  - a. Lulusan Sarjana;
  - b. Memiliki pengalaman minimal selama 8 tahun dalam jabatan manajerial atau profesional;
  - c. Memiliki kemampuan berbahasa inggris aktif;
  - d. Memiliki nilai TOEFL minimal 600 (*paper-based tests*) / 250 (*computer-based tests*) / 100 (*internet-based testes*) atau nilai IELTS minimal 6.5.
4. Calon peserta yang memenuhi persyaratan pada angka (2) dan (3) harus menyampaikan berkas pendukung pendaftaran kepada Sekretaris Unit Eselon I masing-masing dan dikirimkan secara kolektif ke Pusdiklat Pengembangan SDM dengan tetap mempertimbangkan kebutuhan HCDP masing-masing unit. Berkas pendukung pendaftaran harus telah diterima secara kolektif oleh Pusdiklat Pengembangan SDM pada tanggal 17 Maret 2017.



- Company endorsement letter and/or evidence of financial support

### 03 NOTIFICATION

Shortlisted candidates will be contacted for a subsequent phone or on-campus interview.

## REQUIREMENTS

- Bachelor's degree
- Minimum of 8 years of management or senior professional experience
- Demonstrated fluency in English
- For international applicants whose university degree was not taught in English, the programme requires a minimum band score of 6.5 in IELTS, or the following TOEFL scores:
  - 600 for paper-based tests, or
  - 250 for computer-based tests, or
  - 100 for internet-based tests

## CALENDAR

The programme begins with a 1-week orientation period. The first and second trimesters take place from July to February on NTU's Singapore campus. The third term begins in March with a 4-week stay in the United States and ends in Singapore in June.

## PROGRAMME FEE

The programme fee is S\$75,000\*. It covers tuition at NBS-NTU, University of California, Berkeley, and The Wharton School at the University of Pennsylvania; an Overseas Business Study Mission (airfare, transportation, accommodation and certain meals), and examination fees.

- \* The fee does not include airfare to or from the participant's country of origin, transportation, or accommodation in Singapore and the United States.

## SCHOLARSHIPS

Nanyang Business School offers attractive scholarships to outstanding international candidates with a stellar academic record and exceptional professional experience. Admitted candidates will be considered for scholarships, which will be awarded based on need and qualifications.

# PROGRAMME STRUCTURE
